

OPENING HOURS in July and August 2019

Mas administratif : Reception : From Monday to Saturday, from 9 h to 13 h/from 13 h 30 to 18 h . **Every Sunday from 8/07 to 19/08 : from 10 h to 13 h.**

Free WIFI connection under the porch of the "Mas Administratif" (closed at 22 h), around the post-office and in the Discotheque (access time limited to 30 minutes every 6 hours for the last 2 WIFI points).

Post office : From 11 h to 12 h 30 and from 16 h to 18 h (closed on Saturday afternoon and on Sunday).

Swimming-Pool : Open from 9 h 15 to 21 h (23 h during the swimming-pool evenings).

Crazy-Golf : From 15 h to 23 h.

Club "La Sirène": The age groups and opening times will be displayed at the entrance.

Compulsory presentation of both the Resident's card and the Identity Document.

Tennis : Book at the tennis house from 8 h to 20 h. The courts can be reserved with payment of a €10 deposit that is refunded when the court keys are returned at the end of the game. The individual tennis card is free and mandatory for shareholders, next of kins, non paying guests and paying guests. Daily visitors must have a multi-leisures ticket (€4) sold at the tennis office or at the "Mas Administratif".

ENTERTAINMENT ACTIVITIES : weekly programmes can be found on the internet site, on information boards and via the Flash Code. You can also visit the "Point Infos" near the mini-golf.

People are entirely responsible for their own participation in any activities inside or outside the Domaine. The Domaine is not responsible for any theft which occur during these entertainment activities.

Medical Emergency or Accident :

1/ Call : SAMU (Emergency medical Service): 15 (or 112 with a cell. phone)/Fire Brigade : 18
SOS Doctor : 02.33.01.58.65/To be provided with the address of the duty-pharmacy : 32.37.
Medical centre : located in the Nursery near the swimming-pool, from 8/7 to 16/8, everyday from 14 h to 16 h (except on Saturday, on Sunday and public holidays) (the schedule will be displayed).

2/ In case you have called the SAMU or the Fire Brigade for an intervention, please immediately inform the gate-keeper.

3/ Important reminder :

- Several DEFIBRILLATORS are available within the Domaine : some are free access (on the wall of the Medical centre and under the awning of the Bowls club), others are under control (in the lifeguards surveillance office and in the sports local at the football field).

- A Speed'Aid bag which can be used by anybody in case of an emergency at the swimming-pool i.e an accident as well as an oxygen tank with all the necessary material have been placed into a cabinet at the swimming-pool.

SECURITY IS EVERYONE'S RESPONSIBILITY

In case of an emergency, call the Domaine 04.98.11.84.40 (24 h/24) or use the emergency call box placed on each shower block.

Your access and your staying on the Domaine

Associates and Associate's next of kins : present yourself at the "accueil" to be given a temporary sticker for your car and to complete the A form. The sticker for the current year will be provided at the "Mas Administratif" (free sticker) (you must get to the "Mas Administratif" within 48 hours to be delivered this sticker under compulsory presentation of the car log book and a valid insurance certificate for the car. Moreover, the shareholders only will have to present a liability and fire insurance certificate as well as the notice of assessment of the Council Tax for their main residence). **You can pre-register on the [Domaine Website](#).**

paying and non-paying guests : present yourself at the "accueil" to complete the B Form (completed and signed by the Associate and you). You will be given the temporary sticker for your car under compulsory presentation of the car log book and a valid insurance certificate for the car.

Paying guests : in addition to the B Form, **compulsory** presentation of a copy of each entring person's Identity Document is required. Access will be refused to any person not mentioned on the B form. Go to the "Mas Administratif" **right away** to get a sticker for your car and the resident's card.

Non-paying guests : present yourself at the "accueil" to complete the B Form, accompanied by the Associate and to be given a temporary sticker for your car. Then, **right away**, go to the "Mas Administratif", **always accompanied by the Associate**, to get a sticker for your car and the resident's card so that you be considered as a non-paying guest. **The associate must be present on the plot throughout your stay.**

Visitors : if you stay only for the day, you must be met by the resident at the "Accueil" where you will have to complete formalities (you will be asked to deposit your Identity Document that will be handed back to you at your departure the same day). If you want to accede to the leisure facilities, you will have to get multi-leisures tickets sold at the "Mas Administratif" or at the Tennis House.

NOTE : **If you want to prolong your stay on the Domaine, you will have to present yourself at the "Mas Administratif" accompanied by the resident the next morning at the latest.**

Important notice :

The resident's card : is compulsory for anyone aged 7 years and over (presentation of a recent photograph and proof of age for children under 18). It allows access to the Domaine, to the leisure facilities and to the commercial center.

If you have lost or destroyed this card : you will be provided with a duplicate at the "Mas Administratif" after a check of the registration of your stay ; price : € 6,80.

The card is personal and should not be loaned or exchanged. In case of forgery or attempted forgery the card will be seized and the owner sanctioned (this could mean expulsion from the Domaine).

The car sticker is compulsory for any registered vehicle (including trailers). It must be stuck on the right hand side of the windscreen or on the mud-guard of a motor-bike or scooter, or on the front gate of the trailer.

Cleanliness within the Domaine : The sorting of rubbish is applied on the Domaine and must be respected. Please follow strictly the instructions displayed on the dustbin

block. No rubbish or large objects should be left outside trash containers or the bulky waste skips (open on Monday and Friday from 9h30 to 11h30).

ATTENTION : for security reasons, all vehicles entering the Domaine are under video surveillance. A registration plate reading system allows the automatic opening of the barriers. Moreover, the drivers, as well as every passenger of their vehicle should prove they are authorized to enter the Domaine, spontaneously presenting their resident's card to the gate-keeper in case of control. Same requirements for cyclists, moped drivers and pedestrians.

Security and circulation :

- Controls and night patrols will be operated inside the Domaine by authorized security staff. Some areas are under video surveillance.
- The Discothèque is a Private Club EXCLUSIVELY reserved to those persons holding a Resident's Card, with age restrictions (compulsory proof).
- Noise nuisance between 0 h and 7 h will result in sanctions and even exclusion of reoffenders in the case of recurrence.
- French Highway Code rules apply to anyone throughout the Domaine.
- Camping cars (residence inside is forbidden), boats, trailers, professional vehicles must be parked on the parking behind the "Mas Administratif" or on the parking near the area « Petits Loups ».
- Dogs must be kept on a leash at all times on the Domaine. Their vaccination book must be up to date. Animal owners are required to **clean up after their pets. Dogs of category 1 and 2 are forbidden on the Domaine.**
- The consumption of alcohol and illegal substances is forbidden in public areas. Any drunk people will be denied entry at the Discothèque, at the swimming-pool etc...
- The sale and consumption of any kind of drugs are forbidden. Any offenders will immediately be excluded from the Domaine.

BEWARE OF FIRE:

- Read security instructions and have a look at the new evacuation map. When evacuation orders are given, follow the instructions given by the security services.
- Barbecues with flames are strictly forbidden on the Domaine.
- The use of fireworks and firecrackers is strictly forbidden.

BEWARE OF HEALTH RISKS :

Prevention and fight against mosquitos : most of them are carriers of serious diseases. We must prevent them from proliferating by drying stagnant water on and around your plot (saucers under vases, permanent puddles etc...).

Responsibility of the occupants : The Associate has a civil and financial responsibility for both his own behaviour and that of his guests toward the Society (ref. art.11 of the Statutes). Sanctions resulting in permanent exclusion from the Domaine will be imposed to any offenders.
